The San Anselmo Chamber of Commerce and the San Anselmo Community Foundation (SACF) are thrilled to announce that our fundraising efforts for the SACF 2020 San Anselmo Recovery Fund has raised more funds than the number of grant applications received in July, so we can now accept a second round of applications.

The \$1,000 (one thousand US dollar) each individual grants are to assist qualified San Anselmo small businesses with re-opening and/or recovery. Completed applications for this second round of grants must be mailed to San Anselmo Community Foundation, PO Box 2844, San Anselmo CA 94979, postmarked on or before **October 15th, 2020**.

Applications will then be reviewed by the SACF Recovery Fund to insure they meet the qualifications for approval. As available, funds will be granted within two weeks of approval.

Due to the potential of more applicants than possible available grants, we ask that you carefully consider your application to allow those truly financially challenged small businesses in San Anselmo to have access to the grants.

Should SACF receive more applications than funds available, all qualifying applications will be placed into a lottery, with the remaining applicants in queue for grants pending any subsequent donated funds.

We look forward to supporting our local merchants with these small business grants and the comprehensive marketing and advertising campaign aimed to drive commerce and promote our economy in San Anselmo.

Applications must be completed, signed and mailed, postmarked no later than October 15t, 2020

- ✓ Subcontractors working under a primary business license, such as an independent consultant
- ✓ In Bankruptcy, insolvency proceedings, pending/outstanding judgements, tax liens, pending lawsuits
- ✓ Conviction of a criminal offense committed during and in connection with a declared disaster
- ✓ Non-profit businesses and organizations
- ✓ Suspension or debarment from contracting with the federal government or receiving federal funds
- ✓ No conflict of interest: Board Members of the San Anselmo Chamber of Commerce, San Anselmo Community Foundation, employees of the Town of San Anselmo or County of Marin
